#### **Portfolio Allocation**

At the end of September, the GTAA portfolio adopted a cautious stance, bringing its exposure to risk assets from 90% to 20%.

During October, the strategy had a 10% allocation to Japanese equities and a 10% allocation to high yield bonds, with the remaining 80% of the portfolio invested in short-term investment grade corporate bonds.

In terms of performance attribution, our 10% position in Japanese stocks declined 2.6% and our 10% position in high yield bonds fell 0.3%.

The remaining 80% of the portfolio which was allocated to short-term investment grade bonds declined 0.5% for the month.
